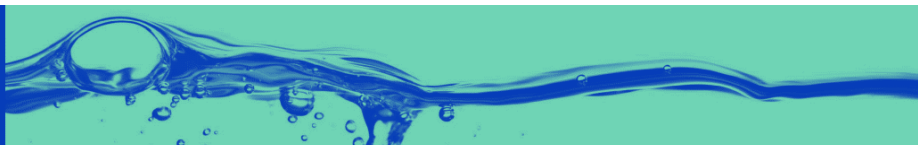

4.1. Description of first aid measures

Inhalation	Unlikely route of exposure as the product does not contain volatile substances.
